### *FEES WILL BE BASED ON THE LOCAL CONSTRUCTION FACTOR*

*Roof Permits.....\$ 25.00*

*UP to \$2,000.....\$ 35.00*

*\$2,001 to \$30,000.....\$ 1.00 for each additional \$1,000 up to \$30,000*

*\$30,001 to \$50,000.....\$ 75.00*

*\$50,001 to \$100,000.....\$100.00*

*\$100,001 to \$200,000.....\$125.00*

*\$200,001 and up.....\$150.00*

*All inspections required for mobile home installation.....\$50.00*

*Installation of Swimming Pools ..... \$35.00*

*Installation of wood stoves or similar units.....\$35.00*

*Chimney inspections (fire related or new construction)....\$35.00*
