The Public Hearing opened at 4:30PM following the Pledge of Allegiance.

The Town Clerk stated the Public Hearing to present the 2022 Preliminary Budget for the Town of Carrollton now open and asked if there was any interested person who desired to be heard.

Clerk Provided affidavit of Notice for the Public Hearing. Clerk stated there was no Correspondence regarding Preliminary Budget for 2022.

Comments For or Against the 2022 Preliminary Budget: **None.**

The Town Clerk stated the Public Hearing is also to present the Local Law 1-2021 as written:

**Town of Carrollton Local Law 1 of 2021 to Override the Tax Levy Limit Established in General Municipal Law §3-C**

**Be it enacted by the Town Board of the Town of Carrollton as follows:**

**Section 1.** Legislative Intent: It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Carrollton pursuant to General Municipal Law §3-C, and to allow the Town of Carrollton to adopt a budget for the fiscal year beginning January 1, 2022 and ending December 31st, 2022 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-C.

**Section 2.** Authority: This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-C, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by a vote of at least 60% of the Town Board.

**Section 3.** Tax Levy Limit Override: The Town Board of the Town of Carrollton, County of Cattaraugus, is hereby authorized to adopt a budget for th fiscal year 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-C.

**Section 4.** Severability: If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

**Section 5.** Effective Date: This Local Law shall take effect upon adoption.

The Town Clerk asked if there is any interested person that desires to be heard.

Clerk provided affidavit of notice of Public Hearing for Tentative Local Law 1-2021 to Override Tax Cap.

Clerk stated there was no correspondence received of the tentative Local Law presented.

Comments to be Heard For or Against Local Law 1-2021 to be adopted: **None.**

Supervisor Rinfrette declared the Public Hearing Closed at 4:55pm.
